In order to avoid conflicts with the IAFF's ALTS, we have moved the 2018 WSCFF Legislative Conference to early January and are trying something we've talked about for a long time: having the whole conference in one day!

Enclosed is the registration information. Please return your completed registration form and payment to the WSCFF office by **Friday, December 15, 2017**. Your local may send as many participants as you deem necessary. There is a \$50.00 fee per person to help offset costs of the conference. Note: Per Resolution 06-08, registrations received after December 15, will cost \$75.

Please make your room reservations directly with the Hotel RL before **December 15, 2017**. You may make your reservations on-line; please see the enclosed accommodations sheet for more information. ***If you reserve more rooms than you need, and then cancel any or all of your rooms after the block period is closed, the WSCFF will be charged for a percentage of those rooms.*** This is called attrition in our contracts with the hotels. Please plan ahead and confirm your room reservations no later than Friday, December 15, 2017.

Registration will begin at 7:00 a.m. on January 9, 2018. The conference will start at 9:00 a.m. with a review of our legislative agenda. Your district representative will make your appointments with your legislators and notify you of your meeting schedule. Between 8:30 a.m. and 6 p.m., the WSCFF will provide buses to shuttle you between the Hotel RL and the Capitol for your meetings.

A WSCFF Legislative Briefing Book will be provided in your registration packets and will contain information useful to you when talking to your legislators. A copy of the book will be sent to each Legislator prior to January 9, and the information in the Briefing Book will be posted on our website, [www.wscff.org](http://www.wscff.org), by the end of December.

A buffet-style dinner will be available to fire fighters at 5:30 p.m. that evening. The legislative reception will follow at 6:30 p.m. At this function, please seek out your legislators for follow-up discussions. You will not need to check in or register for this reception; simply proceed into the banquet room. This will help relieve congestion for legislators and guests who do need to check-in and pick up nametags at the registration desk.

The event is over after the reception, with no session on January 10. The Hospitality Room will still be open the nights of January 8 and 9. Please make responsible travel plans...our rate at the Red Lion is good for the nights of January 7, 8, and 9.

**Reminder: the WSCFF office will be closed December 22, 2017, through January 1, 2018, for the Christmas/New Year holidays.**

##### **Northbound or Southbound I-5:**

Exit 104 to Highway 101. Take the Crosby Boulevard/Auto Mall/Cooper Point Road exit and turn right onto Auto Mall/Cooper Point Road. Turn right at the first light on Evergreen Park Drive in front of AM/PM. Turn right at South Evergreen Park Drive. Follow around bend about ½ mile and turn right into Morris Business Park on Lakeridge Way, straight to Red Lion Olympia Hotel.

##### **From Olympia Peninsula:**

Take Highway 101, Olympia. Exit at Crosby Boulevard/Auto Mall/Cooper Point Road exit. Turn left over the freeway. Turn right at the light on Evergreen Park Drive in front of AM/PM. Turn right at South Evergreen Park Drive. Follow around bend about ½ mile and turn right into Morris Business Park on Lakeridge Way, straight to Red Lion Olympia Hotel.
