2016 WSCFF Benevolent Fund Scholarship Awards

The Washington State Council of Fire Fighters is pleased to announce the recipients of the 2016 Benevolent Fund Scholarships. The WSCFF Benevolent Fund will disburse \$40,000 toward furthering the education of high school seniors whose parents are affiliated with the International Association of Fire Fighters and the Washington State Council of Fire Fighters.

WSCFF Board Members Jeff Wainwright (2nd District), Brian Hurley (5th District), John Stockman (7th District), and two members at large, Grant Larsen (Local 31) and Layne Bladow (Local 1488), met to finalize the rankings for the 2016 scholarship awards.

The panel was very impressed by the students who applied for the scholarships and are proud of their individuality, commitment to academics and understanding of what unions have done for their families and communities. The panel read, scored, reviewed and ranked the 44 applications primarily based upon their cumulative grade point average, high school activities (clubs, sports, work), and an essay.
