## Resolution 19-02 Establishing Retiree Organization Sent to IAFF for Approval

"The purpose of the Retiree Association is to provide retired WSCFF members a unified voice, improved access to and sharing of information, the ability to engage with and give input to the WSCFF on issues impacting retirees and their beneficiaries, and the ability to connect and network with each other and the active membership."

F or nearly a year, the WSCFF Executive Board, in consultation with IAFF DVP Ricky Walsh, worked to craft Resolution 19-02. We sought input from the Retired Fire Fighters of Washington, other IAFF state organizations and WSCFF retirees to create an addendum to our current WSCFF Bylaws, adding a Retiree Association within the WSCFF. The revised document has been submitted to the IAFF for final approval.

The intent is to close the gap between active and retired members. Many retirees have expressed an interest in maintaining contact with the WSCFF and the profession in which many spent their entire careers. Retirees recognize that the WSCFF has worked hard, since our inception in 1939, to push for better laws that protect our members, pensions, the right to collectively bargain, job security, safety, and much more. They also understand that the results of that work are not limited to active members.

The WSCFF Retiree Association will provide a channel for communication and a voice for retirees. Initially, the advisory board will be appointed by the WSCFF President and WSCFF Secretary-Treasurer. It will be comprised of three LEOFF 1 retirees, three additional WSCFF retirees, and chaired by the WSCFF Vice President, who will represent the Association to the WSCFF Board and Legislative Team.

Over the years, there has been a lack of solidarity among retirees on some issues that have come before the Washington State legislature, which caused elected officials to hesitate to act on these matters. The Retiree Association will allow the WSCFF to present the concerns of retirees and speak on their behalf. This unified voice will assist in maintaining and promoting positive legislation affecting retirees and their families. We are excited to take this positive step for the WSCFF and our retirees.

We will communicate the IAFF decision on the proposed change to the bylaws. Check **wscff.org** for more information. If you are interested in serving, or for more information, please contact the WSCFF office.

Convention actions will result in a per capita rate raise from \$24.14 to \$24.48. Of the 34-cent increase, 28 cents was from Resolution 19-01 with the approval of our budget with CPI increases. Resolution 19-15 changed the meeting frequency of the trustees from four to five meetings a year at a three-cent per capita cost, and Resolution 19-24 expanded the Health and Safety Committee membership by two members at an additional three-cent per capita cost.

The Health and Safety Committee brought forward Resolution 19-19, which directs the WSCFF to create version 2.0 of the Healthy In, Healthy Out best practices guide.

The Seminars and Education Committee resolutions directed the WSCFF to investigate the possibility of including all labor groups during our educational seminar each year in Resolution 19-16 and expanding our selection of classes in Resolution 19-17. The Convention Site Committee forwarded Resolution 19-13 to the floor, and convention will be held in Walla Walla in 2022 and hosted by Local 404. Resolution 19-23 addressed convention site in 2021 to be held in SeaTac and hosted by Local 1747.

### **2019 Legislative Team Report**

The 105-day 2019 Legislative Session saw success on several fronts for a newly configured WSCFF Legislative Team. Former Legislative Liaison and recently retired fire fighter, Bud Sizemore, joined AJ Johnson and officers Dennis Lawson, Dean Shelton, and Greg Markley, who, along with Session Lobbyist, Nich Gullickson, made up your legislative team. This year's achievements were built on decades of legislative and political advocacy and thousands of hours of countless individuals before the 2019 session even started.

#### **PRESUMPTIVE COVERAGE**

n nearly every session for the past 10 years, the WSCFF has introduced an expansion to the presumptive disease statute (RCW 51.32.185) based on the higher incidence of cancer in fire fighters and the difficulty in proving causation to a particular exposure. HB 1913 was introduced after multiple stakeholder meetings that included the Washington Council of Police and Sheriffs (WACOPS), employers, legislative staff and Representative Beth Doglio. Evidence supported the addition of mesothelioma, stomach cancer, nonmelanoma skin cancer, cervical cancer and breast cancer in women, along with the inclusion of fire investigators and LEOFF EMT/Paramedics not otherwise covered. Employer groups insisted on the creation of a Board of Epidemiology within Labor and Industries (L&I) to consider any future additions to the presumptive statute. During negotiations, the WSCFF and WACOPS agreed to accept the new

board if employers agreed to support or be neutral on the compromise bill. Our thanks to Representative Doglio for applying the necessary pressure to get that agreement!

In order to pass this, and all of our WSCFF-supported legislation, your legislative team worked to: gather cosponsors, engage with multiple committees, garner majority support within committees, convince committee chairs to bring the bill up for a vote prior to cut-off deadlines, address multiple legislators' fiscal and policy concerns, convince Rules Committee members from both chambers to use limited pulls to make the bill eligible for consideration, convince the leaders of both chambers to bring the bill to the floo, ensure there were enough votes to pass, and answer any inquiries by the Governor's staff so that they will recommend he sign!

#### **LEOFF Plan 2**

Another long-standing issue resolved this session was the bipartisan failure of

the Legislature to make required payments into the LEOFF Plan 2 Benefit Improvement Account. In 2008, the Legislature passed SB 6573 obligating the State to make contributions into a separate pension account for eventual benefit improvements to LEOFF Plan 2. Each succeeding year, through special budget language, the legislature skipped the mandated payments. Very early in the 2019 session, through member meetings with key legislators, it was clear that this year would follow the same pattern.

Your legislative team, in consultation with the WSCFF Executive Board, explored alternatives and discussed the possibility of trading the payment required by the current law (which had never been funded from the General Fund) for a greater amount out of our LEOFF Plan 2 reserves to the Benefit Improvement Account. The team informed the law enforcement officer (LEO) LEOFF organizations that we were going to float the idea with legislators. We then met with House and Senate leadership and budget writers and received very positive feedback on the concept. The WSCFF Legislative Team next met with all of the LEO groups to bring everyone up to speed and proposed introducing legislation. Both WACOPS and Council of Metropolitan Police and Sheriffs (COMPAS), representing about 80 percent of LEO workers, supported the idea. The last recognized group, the Fraternal Order of Police (FOP), opposed it.

The decision was made to draft and work to pass HB 2144. This was no easy task. The divide in member groups and a separate proposal to merge LEOFF 1 and LEOFF 2 complicated matters. Your legislative team participated in all discussions once we were informed of the merger proposal, and a bill was never formally introduced. HB 2144 passed and was signed by the Governor on May 13, 2019, which created a transfer of \$300 million from the LEOFF Plan 2 fund to the LEOFF Plan 2 Benefit Improvement Account on July 1, 2019. Any future benefit improvement will require a LEOFF Plan 2 Board proposal and legislation.

While these two bills consumed much of our time and effort, we attended to several other high-priority issues. Those that we advocated for passed, and those that we had concerns about did not. Below is a brief description and the outcome of those issues:

**HB 1909** – Provides privacy protections for PTSI claims – Passed

**HB 1575** – Clarifies labor issues post-Janus – Passed

Additional \$300,000 for JATC in final budget – Passed

**SB 5010** – Annexation of Unprotected Lands – Passed

**SB 5355** – Correcting LEOFF Plan 1 Era Pension Gap – Passed

**HB 1188** – Creating Rangeland Fire Associations – Failed

**SB 5517** – Assessing Transport Quality Assurance Fee – Failed

While it didn't seem possible in the last week of April, the Legislature completed work on time, and the WSCFF had a very successful session. What's next? Delegates at the 80th WSCFF Convention passed resolutions that will shape our efforts in the 2020 Legislative Session.

In the meantime, locals across the state are working on campaigns that will determine who leads our cities, districts and departments, as well as critical funding measures. These elections are won by those who participate. Please take part in the parades and community events, step up, make the calls, and ring doorbells when your local makes the request!

Stay safe, thank you for your support of the WSCFF, and remember to vote this fall.

The Health and Safety Committee includes Jeremy Dixon, Local 437; Adam Jackson, Local 726; Dan Ward, Local 876; Steve Austin, Local 1052; Chris Mortensen, Local 1433; and Neil Agren, Local 3828. Recent convention action has added several items to the committee's agenda for the coming year.

The Healthy In, Healthy Out best practice manual, funded by a Department of Labor and Industries (L&I) Safety & Health Investment Project (SHIP) grant, was completed almost five years ago and continues to make positive change toward reducing risk and exposure to carcinogens in the fire service. The Washington State Legislature recognized the role of Healthy In, Healthy Out by passing Substitute Senate Bill 5175, which was signed by Governor Inslee in April. The legislation requires L&I to establish best practices to improve safety and health outcomes for fire

fighters. The best practices will include reducing the risk of exposure to carcinogens, and the creation of a governance board to identify, evaluate, monitor and report safety and health hazards. It also provides L&I a funding mechanism and, in the future, the possibility of employer rebates of workers' compensation premiums if they use best practices.

Delegates at the WSCFF Convention recognized the need for continued guidance and adopted Resolution 19-19 *Healthy In, Healthy Out* Version 2.0. The new version will include resources and best practices for sleep deprivation, wellness, cardiac and behavioral health issues. The WSCFF will seek another SHIP grant, and the committee will provide updates on this process and the subsequent work plan.

The leaders at convention also adopted Resolution 19-24, which adds two members to the standing Health & Safety Committee. The IAFF and WSCFF have focused on our members' behavioral health as we see more of them in need of professional support. One addition to the committee will be a WSCFF member who has done work within the behavioral health field, and the second position will be filled by the President or designee of the Firefighter Cancer Support Network, Washington Chapter. Including these two positions will reduce duplication of work and provide a more holistic approach to address member needs.

The health and safety of our members has always been at the heart of the work

of the WSCFF. The labor movement was founded to improve working conditions that lacked rules, regulations, and best practices. Many employees were injured and suffered from diseases and illnesses directly related to their work. As a labor union, we must continue to push and advocate for the health and safety of our members.

We will report to you as this work progresses.

#### **EMS Survey**

Just prior to convention, a survey on EMS issues was sent to each WSCFF local affiliate. We were pleased with the response; 77 of our local presidents or designees took the time to complete the survey. The data collected will be useful for our committee as issues arise. Thanks to all who took the time to respond.

#### Single Role, EMS-Only Employees Position Statement

This is an issue that continues to come up in some of our locals. The WSCFF Executive Board has formally adopted a position on this issue. It can be found on our website. If you have questions or concerns or just want to discuss the issue, please contact the committee at **ems@wscff.org**.

#### **Convention 2019**

Two resolutions came out of the Convention EMS Committee. Resolution 19-09 concerns the DOH requirement for a specific number of intubations per year for a paramedic to maintain their certification. The resolve is to have the requirement changed to allow advanced or difficult airway classes as a substitution for the intubation requirement. There are already several pilot programs in the state that have proven successful. The EMS Committee has a meeting scheduled with DOH to consider rulemaking as an avenue to make this happen.

Resolution 19-10 concerns DOH disciplinary procedures. The resolve is to have the legislative team and EMS committee find a way to have the DOH more closely follow the just-cause principal that is included in almost all of our collective bargaining agreements. This is a complicated issue, and there are several different avenues being considered as a means to solve it. Stay tuned on this one.
